One of this year's gems - WATERisLIFE in partnership with DDB NY Advertising Agency, traveled to Haiti to create a campaign that tapped into universal human truths - tapping into emotions that are deeper than language and cross cultural divides. The #FirstWorldProblems video was created. The campaign attempted to eliminate the #FirstWorldProblems hashtag on Twitter - the first mission to wipe out a hash tag instead of promote it. The campaign is a reflection of WATERisLIFE's pro bono partnership with DDB NY - an opportunity for DDB NY to do work that is meaningful - to add value to people's lives while allowing Agency creatives to use their talent for a great cause. A true gem for WATERisLIFE and the campaign's direct beneficiaries - many in Haiti in need of clean water.

Other highlights from 2012 include building capacity by creating a comprehensive WASH education program in partnership with Project Wet in action in Kenya, Ghana and Haiti. WATERisLIFE utilized Healthy Habits materials in Swahili, Creole and began the translation of Healthy Habits materials in Northern Ghana's tribal language Dagbani which will impact over 309 schools - 38,000 students Continued program development in Northern Ghana has led to furthering the WATERisLIFE Rotary International Funding partnership - an opportunity to bring WASH programs to 290 villages in Tolon and Kumbungu Districts.
