Our continued pro bono partnership with DDB New York, building on the 2012 Award winning Hashtag Killer #First World Problems campaign, flourished as we released the Kenya Bucket List video captivating over 6 million viewers by year end. No child should need a Bucket List. 1 in every 5 children under the age of 5 will die from a lack of clean drinking water. This is one of the most frightening facts we deal with each day. We think about what it must be like to be a 5 year old living in Africa - how it must feel watching other children around you dying from waterborne diseases and dehydration. And when a child's life is cut short, you can't help but think about all the things they could have done. All the dreams they had that could never come true. This is what drove the idea of giving a child their Bucket List. The film is happy and quite sad. We introduced Nkaitole, an adorable 4 year old Maasai boy. He is now a bit of rockstar in his village. And so much has been accomplished thanks to him. But most importantly, Nkaitole's adventure has changed lives. The video has continued to increase media presence and build exponential awareness of WATERisLIFE, ultimately yielding in an increase in donations designated to bringing clean water, sanitation and hygiene solutions directly to the Maasai villages near Amboseli, Kenya. Over 5,000 lives have been impacted with new access to long term clean water.

One of WATERisLIFE's key integrated projects is being implemented in Northern Ghana, where we have mapped donations into village transformations. Water sources are now protected from contamination, point of use filter systems are now a part of every household kitchen, Straw Filter and hygiene programs are integrated into school curriculums and WASH Action Groups have been set up as departments in villages where open defecation was once a way of life. Villages have been awarded Open Defecation Free Status, WATERisLIFE has trained Latrine Artisans in each village to create

6,000 WATERisLIFE Filter Straws and 3,500 point of use filters have traveled with groups, partner teams and organizations around the globe bring instant clean water access to thousands. Deep and shallow water wells have been drilled, pumps have been repaired, water storage tanks installed, and latrines and hand-washing stations created to support where most needed. In 2013 WiL provided hygiene education to over 1500 children and in partnership with Project Wet, created Healthy Habits teaching materials in a variety of native languages to be included in Hygiene Teacher Training Kits.

Two key milestones for WATERisLIFE this year were to establish program development and sustainable growth and to monitor direct impact made by donor investment.
